Welcome to the Live Trading Room,

Thank you for subscribing to our Live Trading Room. You will see that our trading room is professional, honest and transparent. Your experience and success is very important to us therefore, we have gone to great lengths to detail everything you need to know and be familiar with to ensure a positive experience to all our clients.

Please read this PDF in its entirety as it is very important to the quality of your experience in the Live Trade Room as well as your potential profitability.

1. Please familiarize yourself with the welcome packet which you should have downloaded upon your subscription process. If you have not downloaded it yet, the link is available on your receipt from our shopping cart. If you have lost your receipt then visit our website @ <http://solomonfx.com/index.php/forms-and-downloads>. Look under the category Live Trading Room and all download all the material from there.
2. What you will need to know for the Trade Room:
 - a. **Brokers and Platforms:** You can use any broker you feel comfortable with to place your live trades. We will be using the MT4 Platform to display our strategies and indicators. You do not need to access an MT4 platform unless you desire to purchase the indicators. If you do purchase the system, it is possible to simply download a MIGFX MT4 demo account from www.solomonfx.com/files/mig4setup.exe and place the trades on another non-MT4 broker.
 - b. **What you need to know placing trades:** Besides knowing how to place trades, set stop loss and take profit levels on your brokers platform, you will need to know how to close partial positions (a portion of your trade). If you do not know how to do so, we recommend that you contact your broker. We will provide training on how to do so on the MT4 platform. At times (infrequently), the traders will recommend placing pending orders for a particular trade. We will also provide training on how to do this on the MT4 platform. If you are using a non MT4 broker, you will need to contact that broker to learn how to do so.
3. Using GoToWebinar and logging in to sessions
 - a. You will receive your invitation within ½ hour prior to the session. Invitations to the event are sent out between ½ hour to 15 minutes prior to the sessions.
 - b. Using the link provided in the invitation, register for the event.

- c. Once approved, you will then receive a second email with a unique link to access the Live Trading Room.
 - d. If you do not receive an email, be sure to check your spam folder, it will be sent from support@solomonfx.com. Edit your email settings to accept from this web address as well as gotowebinar.com and citrixonline.com.
 - e. If you have a problem please contact support@solomonfx.com.
4. Managing Your Expectations
- a. It may take you a few days to become comfortable with the entire process from logging in to placing trades and following the methodology of our traders.
 - b. To date our systems and strategies have been successful. However, we do have losses. Please use good money management.
5. Conduct in The Trading Room
- a. Professional conduct is required for anyone chatting in the trade room. Anyone using expletives, insulting or discourteous language will be removed from the Live Trading Room for that session.
